An Endowment is a fund in which the principal gifts are held forever in trust and distributions from the earnings only are made once a year, forever.

Contributions to our parish endowment fund are welcome and encouraged. They may be made in lieu of a Capital Campaign pledge, a celebration of a special occasion or as a memorial contribution in honor of a loved one.

A Charitable Gift Annuity is an excellent way to receive an annual fixed payment for life and still benefit St. John Neumann.

Many donors are discovering that a charitable gift annuity increases their income *and* qualifies them for a significant charitable deduction this year.

The donor is guaranteed this fixed payment for the remainder of his or her lifetime. A second beneficiary (such as spouse) may be included in the gift agreement. Upon the death of the donor(s), the principal remaining in the annuity fund will transfer to a St. John Neumann Parish Endowment Fund or a special Fund you establish to benefit St. John's.

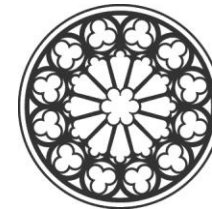

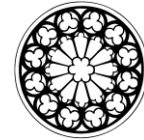
